(As of 01.01.2020, in thousand units)



At the same time, we can develop the employment of small businesses and private entrepreneurship, increase incomes of the population, rational use of free resources and so on. It is worthy to note the high share of private entrepreneurship in the employment of the population and the growth of the income of our people. About 78% of employed people are currently working in this area.

As a result, over the past five years, the share of income from entrepreneurial activity in the population's income increased from 47.1% to 52%, indicating an increase in incomes of the population, in improving the living standards and quality of life.²

As a result of the measures taken to create a business environment, support and further stimulate small business and private entrepreneurship, in January-December 2019, more than 92.9 thousand small businesses (private farmers), or 1.9 times to the corresponding period of 2018. The largest share of small business entities was registered in trade (39.1%), industry (21%), construction sector (9.1%) and agriculture, forestry and fishery (8%). (Figure 2)³



In January-December 2019 the subjects of small business and private entrepreneurship:- Industrial output – 99 139.3 billion sums; (52.1 percent of total industrial production) or 104.8 percent compared to January-December 2018.
