- 2. Freedom in the modern, liberal meaning of this term as freedom for the realization of socially positive needs and abilities of the individual;
- 3. Morality as a quality of human behavior in accordance with universal moral and ethical standards;
- 4. Communication in the family, with friends and other people, mutual assistance;
- 5. Family, personal happiness, procreation;
- 6. Work as an inherent meaning of life and as a means of earning;
- 7. Well-being income, comfort of one's life, health;
- 8. Initiative, enterprise, ability to express oneself, stand out;
- 9. Respect for traditions;
- 10. Independence, the ability to be an individual, to live according to one's own criteria;
- 11. Self-sacrifice as a willingness to help others, even to the detriment of oneself;
- 12. Authority the ability to influence other people, have power over them, compete and achieve success, victory;
- 13. Legality as an order established by the state, which ensures the safety of the individual, the equality of his relations with other people.
