Cheque Bounce Case against Vijay Mallya Adjourned To July 5

No matter what but Kingfisher liquor business will run for ever - the III Special Magistrate Court here is yet to pronounce its order on the quantum of sentence for Mr Mallya, for this default.

On April 20, 2016 the court had convicted MrVijay Mallya and others in connection with bouncing of two cheques worth INR 50 lakh each under relevant sections of Negotiable Instruments

Act.

As our police are very active, issued warrants directing to produce Mr. Vijay Mallya for the quantum of punishment, but our liquor barrel is enjoying by sipping his liquor along with several kingfisher calendar girls and enjoyed watching his IPL team reaching finals.

Mr. Vijay Mallya vacated his premises and Kingfisher officials as being smart and having a foresight with the king of times, the Mumbai Police hence could not find any evidence and the warrants were returned.

Following this, Judge M Krishna Rao adjourned the matter to July 5 with a direction to the complainant to furnish correct address of the accused for issuance of fresh warrants, until then Mr. Vijay Mallya can sip more cocktails.

Lawyer Mr. G Ashok Reddy had insisted that the court pass the sentence against MrVijay Mallya, and saying the court has power to impose sentence even in absence of accused.

The matter relates to cheques issued by Kingfisher Airlines Ltd to GHIAL, which operates the Rajiv Gandhi International Airport here (must be his flying point while he escaped from India),

towards charges for using the facilities at the airport for its Kingfisher Airlines flights.



The court has issued non-bailable warrants against the Kingfisher Airlines, its chairman Mr. Vijay Mallya and senior company official Mr. A Raghunathan.

As per the GMR counsel, a total of 17 cases have been filed against Kingfisher Airlines in courts over outstanding amount of INR 22.5 crore(the amount that he earns in a day by selling his liquor business) an amount owes to GMR, and the cases are in trial.
